1. **ACCESS TO SESSIONS:** you will only need your email address and name to attend any session. You WILL NOT need the invoice, order or ticket you may have received when you registered.

3. **EACH SESSION WILL REQUIRE** that you register or login with your email and password. There are between 4 and 6 different sessions each day – sorry for the redundant requests!
4. **IF YOU WANT TO RECEIVE AN EMAIL REMINDER FOR A SESSION** - you will need to PRE-register for it. REMINDER EMAILS will be sent one hour before each session.
